Congratulations on your admission to Spelman College!

The Office of Financial Aid is here to assist students in financing their college education. The majority of funds administered by the Office of Financial Aid come from federal and state sources, in the form of grants, scholarships, work-study, and student loans. Eligibility for these types of financial aid is determined based on the formula approved by Congress and used by the Department of Education through the Free Application for Federal Student Aid (FAFSA).

Typically, your offer of admission would also include a Financial Aid Award Letter. This year, the Department of Education delayed the opening of the 2025-2026 FAFSA, which has resulted in delayed award letters. The FAFSA is available for you to submit to Spelman College on **December 1st.** The priority deadline to submit your FAFSA is **February 1st.**

The Office of Financial Aid plans to release award letters by March 1, 2025.

A dedicated financial aid advisor is assigned to each student by the first letter of their last name. We appreciate your patience and look forward to helping simplify the path to financial aid. As always, please reach out with any questions.



MERIT SCHOLARSHIPS

First year merit scholarships are managed by the Office of Admissions. Spelman does not require a separate application process for merit-based scholarship consideration, and students do not have to request to be considered. **Transfer students are not eligible for merit scholarships at Spelman**.

Competitive scholarship candidates have a stellar academic record in the most rigorous courses available, strong writing skills, compelling recommendation letters and extensive multiyear leadership or service. The average GPA for merit scholarship recipients for the Fall 2024 incoming class was a 4.1.

Spelman College is a competitive institution where the majority of our students are merit worthy, extremely involved leaders, civic activists, & need financial assistance. With Spelman providing for such a unique, yet dynamic group of young people, our scholarship funds are limited upon entry.

Awarding Timeline

Merit scholarship offer letters are released on the SpelCheck portal at the time of admission.

Merit scholarships that consider need and household income will be released on March 1st. These awards include one (1) Flanigan full ride scholarship, one (1) Smith full ride scholarship, and two (2) full tuition Joan B. Johnson scholarships.


A MESSAGE FROM THE DIRECTOR OF ADMISSIONS **ENROLLMENT DEPOSIT INSTRUCTIONS**

New First-Year and Transfer students who plan to enroll in the College are required to pay a \$500.00 non-refundable Enrollment Deposit. Enrollment deposits may not be waived and partial payments are not accepted.

All deposit payments may be submitted by certified check, money order, credit card or debit card. For payments made by check or money order, please make sure the student's name and Spelman ID number is written clearly on the memo line and mailed to the Office of Admissions.

ENROLLMENT CONFIRMATION

Spelman is a private, independent historically Black women's, liberal arts college. With a strong tradition of excellence, Spelman College selectively admits and enrolls qualified female candidates, regardless of race, color, religious affiliation, national or ethnic origin, physical challenges, or sexual orientation.

Admission to Spelman is done on a very selective basis. All admitted students are expected to maintain the level of academic achievement presented in their applications until their graduation from high school. A final transcript with a grade lower than a "C" is subject to re-evaluation by the Admissions Committee, at which time they may recommend that our invitation to enroll be withdrawn.

Your space in the class and placement in the residence halls are contingent upon the following:

ALL STUDENTS MUST:

• Complete the Enrollment Confirmation Form located on your SpelCheck portal along with submitting the non-refundable \$500 Enrollment Fee by May 1 (New First Year) or July 1 (Transfer).

FIRST-YEAR STUDENTS:

- Receipt of your final high school transcript showing proof of graduation and satisfactory completion of high school by July 1 (fall).
- Students accepted under the Early Decision Plan must also complete and submit the Early Decision Agreement Form located on your SpelCheck portal.

TRANSFER STUDENTS

• Receipt of your final college transcript showing satisfactory completion of courses by August 1 (fall).



FINANCIAL ASSISTANCE AND SCHOLARSHIPS

For consideration, students entering Spelman College must list Spelman's school code (001594) on the Free Application for Federal Student Aid (FAFSA). The FAFSA online form is available at https://studentaid.gov/h/apply-for-aid/fafsa

- FAFSA online form will be available December 1st.
- The deadline to submit the FAFSA for priority consideration is February 1st.

Please note that institutional scholarship recipients are selected by the Office of Admissions, using information submitted with the application for admission. IMPORTANT INFORMATION FOR FINANCIAL AID APPLICANTS

- Students and parents should create a Federal Student Aid (FSA ID) before initiating the aid application at studentaid.gov.
- Complete the Free Application for Federal Student Aid (FAFSA) at: studentaid.gov
- The Spelman College school code is: **001594**
- Please make sure social security numbers are correct.
- Remember to provide your full legal name. Common errors like using nicknames or middle name instead of your first name can cause processing delays
- Make sure both the student and parent/guardian sign the FAFSA form with your FSA ID.

PRE-ENTRANCE HEALTH FORM INFORMATION

The health and safety of our community is important to us. All students are required to complete and submit the Pre-Entrance Health Form which is only available online at:

Students will gain access to the Pre-Entrance Health Form beginning **April 1st**. Completion of this form is an important step in our check-in process for all new students. Students are not allowed to move into a residence hall, participate in orientation programs, or register for classes without a completed health packet on file with the Department of Student Health Services. The health packet must be submitted to the Department of Student Health Services (SHS) no later than **June 1**.

- Some immunizations required by Spelman College are not required in every state, so it is important for you to review required immunizations with your doctor as soon as possible.
- SHS requires a doctor's original signature on this document. We are unable to accept faxed or electronically transmitted forms.

RESIDENCE HALL ROOM RESERVATION PROCESS

FIRST-YEAR STUDENTS

All first-year students are required to live on campus if they meet communicated deadlines and expectations in a timely fashion. Only those students who have accepted their admission and deposited with the College will be able to access the Online Housing Application and Housing Lease which will open on **April 1st.** Once students have submitted a housing application and a signed housing lease, they will be eligible to participate in the room reservation process. Students will need their Spelman username and password to access the system. These credentials are provided by the Admissions Office after the enrollment deposit has been processed.

It is possible that some students may be placed on a waitlist for on-campus housing if they complete the housing application later in the process or the size of the incoming class is particularly large. If this occurs, students will be assigned as quickly as possible as rooms become available.

Any individual who misses the **May 7th** deadline to complete a housing application will not be eligible to live on campus.

Both the housing application and housing room reservation process are found online on the Housing Dashboard at www.spelman.edu/ housing. All correspondence related to the room reservation process and housing assignments will be sent to the student's Spelman email address.

Students who require a room assignment to address a medical need must complete appropriate documentation with the Spelman College Student Access Center. All guidelines and forms for the medical accommodation process can be found online at: https://www.spelman.edu/student-life/housing-and-residence-life/special-needs-and-your-room-assignment.html

Any approved medical accommodation will be communicated to the Housing & Residence Life office. If an accommodation cannot be met immediately, the student will be placed on a priority wait list for the type of room needed. You are strongly encouraged to complete this process as soon as possible for the greatest likelihood that your medical accommodation can be met.



IMPORTANT INFORMATION ABOUT THE HOUSING ROOM RESERVATION PROCESS

- Students will not indicate residence hall preferences or desired roommates. They will select their assignment from available rooms during the room reservation process.
- Students with approved medical accommodations are expected to select a room that meets their medical needs.
- The Housing and Residence Life office will not manage preferred roommate assignments. Students hoping to live together must communicate with one another and coordinate their room selection for that purpose.
- The ability to live with your preferred roommate is not guaranteed.
- Students who complete the requirements for assignment later in the process may be placed on a waiting list until a permanent assignment becomes available.
- Students who miss the May 7th housing application deadline will not be eligible to live on campus at Spelman.

IMPORTANT INFORMATION ABOUT THE HOUSING ROOM RESERVATION PROCESS FOR TRANSFER STUDENTS

Housing cannot be guaranteed for transfer students. Transfer students may submit the online housing application and lease to indicate their interest in living in Spelman Housing. If housing becomes available, priority in assignment is given to transfer students under 20 years of age.
